Parking Management Strategies: Please see previously submitted cover letter for details. Management and operation of bays included in the lease of 251 Oxford will be undertaken by the applicant (partnership leasing the property). Maintenance of bays is the duty of the property owner. The applicant and his partners will manage the details set out in this plan, including enforcement and signage. Comprehensive public transport instructions will be provided to all clients of the centre as a way to promote alternative transport options. Two of the three psychologists live in close proximity to 251 Oxford St and so plan to walk/cycle to the centre. As per the cover letter, all three psychologists have alternative jobs and plan to work at the centre part time (to a total of 1 Full Time Equivalent staff member). Please also note that the 3.5 bays per consulting room stipulated in the council regulations represents a massive over-estimate of usage given that psychologists will each see a single individual or family per consult.
